~VERY IMPORTANT!!! ~ AKC BREEDER COMPLIANCE INSPECTIONS

The American Kennel Club (AKC) conducted inspections of various dog breeders here in our State in September and October 2003. A Club Member who is a breeder of Chihuahuas, and who was inspected by the AKC brought this to the Club Board's attention. This breeder member thought that our Club Board was responsible for the AKC inspection. The Club is reporting on this situation in this Club newsletter, because the Board does not want the Chihuahua breeders in this State to have any misconceptions about the Club's concerns regarding Chihuahua breeders in the State. We have included in this newsletter the entire text of three letters. One is from the breeder member to the Chihuahua Club of Hawaii board regarding the concern that the AKC inspections may have been instigated by the Club Board. The second letter is from the Club board to the AKC. The third letter is from the AKC to the Club Board.

A note to all Chihuahua Breeders here in the State—

The Chihuahua Club of Hawaii does not have a policy regarding specific Chihuahua breeders in the State. However, we support educating members about breeding and breeders in general and are concerned about animal welfare. If the Club is presented with evidence that the breeder is not operating in compliance with the AKC Rules and Regulations, and/or there are significant and verifiable customer complaints against any Chihuahua breeders within or outside of the Club, the Club will notify the appropriate agencies within the State of Hawaii and/or the American Kennel Club, as necessary. If the Club notifies any agencies or the AKC, the Club will also make a good faith effort to notify the breeder about the matter at the same time. If you are a breeder and you have a problem with the Club, please contact us directly to discuss your concerns.

LETTER FROM THE BREEDER MEMBER TO THE CLUB BOARD

"November 12, 2003

Dear Chihuahua Club,

Included with my renewal membership check, is a copy of my AKC Care & Conditions Report, done by AKC Inspector Robert James on 10-01-03. As you can see, I passed with no problems. I was told, certain Chihuahua Breeders were singled out for this because of a request made by your Board. The handful of us under such scrutiny—all passed, but were quite hurt as to why we were targeted.

Yes, some of the Breeders do operate as a business and do depend solely on breeding as a way to make a living—but that is not against the law, as long as it is done in the humane manner they have proved now to the AKC to be doing. Please remember, those operating with a business license, would have the option of recourse to the Club, should they find out it has caused them harm. The consequences of slander and defamation of character can be very serious.

Let's all try to work together for the good of the dogs, and the betterment of the breed; not against each other. This State is too small for those kinds of actions..."

LETTER FROM THE CLUB TO THE AKC

Dear Mr. Robinson,

We have received a letter from one of our Club members, along with a copy of an AKC inspection report, as attached. The Club member is informing us of the inspection, but also expressing a concern that the Chihuahua Club of Hawaii had made a request that various Chihuahua breeders in our State be inspected. After receiving this letter on November 19, 2003, the Club Secretary emailed the AKC, and also called the AKC North Carolina office and spoke to Marsha. Marsha confirmed that the Chihuahua Club of Hawaii did not make a request to the AKC for Chihuahua breeders in Hawaii to be inspected. Marsha indicated that the inspections were completely routine in nature, and were not instigated by our Club or any private individual.

We are writing you this letter to request that the AKC confirm this in a written letter back to the Club. We would greatly appreciate having a letter to this effect in order to allay any concerns among our Club members and in general around the State. We also wish to note that if it ever becomes necessary for the Club to make a concern known to the AKC of any practices not in accordance with the AKC rules and regulations, that the Club would also notify the breeder that the AKC has been contacted.

LETTER FROM THE AKC DIRECTOR OF INVESTIGATIONS AND INSPECTIONS TO THE CLUB BOARD

Dear Ms. Maki,

This is in response to your correspondence dated November 20, 2003, regarding your request for written information regarding inspections in Hawaii.

The American Kennel Club (AKC) routinely conducts inspections of dog breeders located throughout the United States that register 7 or more litters or customers that conduct 25 or more registration transactions annually. The inspection includes dog records, on-dog identification, DNA collection, dog and kennel conditions. These inspections are designed to ensure the health, safety and welfare of dogs registered with the AKC, and to protect the integrity of the AKC registry. The AKC is the only dog registry in the world that has an inspections staff that routinely conducts inspections to monitor compliance with their rules and regulations.

The AKC conducted inspections of customers in Hawaii during September and October 2003 who met inspections criteria. None of the inspections conducted in Hawaii during this time were complaint generated. Thank you for your inquiry.

DOGGY RECIPIES

Chi-liver Cake

pound of chicken livers
 1\4 cup salad oil
 1\2 cup water
 3 or more cloves of garlic
 2+cups of flour
 (optional goodies that you can add-bacon bits, grated cheese)

Place liver, oil, water, garlic and the optional goodies in a blender or food processor, and liquify them. Pour them into a bowl, add flour until you have a stiff but sticky batter. Pour into greased pan. Bake at 350 degrees for at least 1 hour. After 1 hour cut a small slice and if any pink is showing, return it to the oven for about 15 minutes more- it's important that it be well done.

Oatmeal Wheat Germ Biscuits

- 3 c Whole wheat flour
 - 3 c Oatmeal
- 1/2 c Regular wheat germ
 - 6 T melted bacon drippings or margarine
- 1/4 c Molasses
 - 1 c evaporated milk
 - 1 c water

Mix dry ingredients together. Add remaining ingredients and blend until well mixed. Dough will be stiff. Chill for 1/2 hour. Take rounded teaspoons of dough and roll into balls. Flatten and place on a lightly greased cookie sheet. Bake at 300 degrees F for 1 hour.

Bowser Bagels

2 1/2 cups white flour
** see below for wheat allergies**
1/2 cup whole wheat flour
1 tsp. vegetable oil
1 egg
1/4 tsp. baking powder
1/2 tsp. baking soda
1 cup finely chopped vegetables (carrots, spinach, brocolli, zuchinni) (one kind or mixture of any)
1 Tbsp. minced garlic
3/4 cup water

Combine all dry ingredients and mix in wet ingredients. Knead by hand; form into balls (approx. 1 1/2 - 2 inches in diameter). Flatten dough balls, poke a hole in the center and form into bagel shape. Place on lightly greased baking sheet. BAKE at 350* for 45 - 55 minutes. Cool completely on a rack. Should make about 1 1/2 dozen bagels.

*** For variety try Fruit Bagels- instead of vegetables use 1 cup of chopped frozen cranberries, blueberries, or fresh chopped apples or grated orange peel. (alone, or a combination of any).***

** for dogs with known wheat allergies use Kamut, Spelt and or Rice flours** (available at Health Food Stores)
